

Strategy description

The FCT 1e 45 strategy is a multi-manager investment strategy independently defined by the FCT 1e Board of Trustees and made available to FCT 1e company affiliates and insured members.

The investment strategy is diversified across equities (45%), bonds, real estate and alternatives. It is biased towards passive funds to lower the costs and selectively targeting active best-in-class funds to improve risk and return. The strategy is rebalanced monthly back to target weights.

The strategy is appropriate for investors with an above-average capacity / willingness to take risks and an investment horizon of 7 or more years.

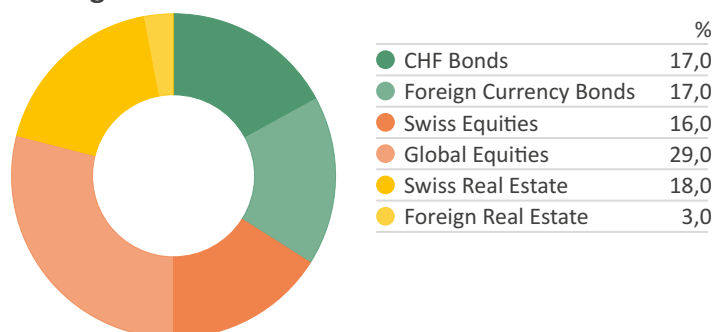

In both cases, performance is computed as a time weighted rate of return (TWR) on the investment portfolio, excluding operational cash. Performance is shown net of indirect fees (charged inside the funds) and gross of direct fees (charged outside the funds). Foreign currency exposure is after currency risk hedging. Proportion of ESG investments correspond to ESG-labelled funds as considered by the asset manager.
